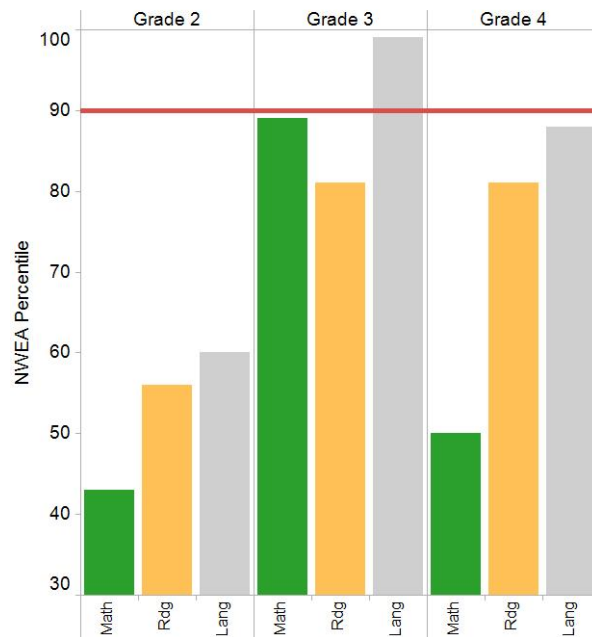

Target Area One: Student Learning

Goal One: By 2011, the percentage of WWS students meeting their individual growth targets on the NWEA Math, Reading, and Language Usage MAP Assessments will reach the **90th percentile** of all students taking the test across the nation.

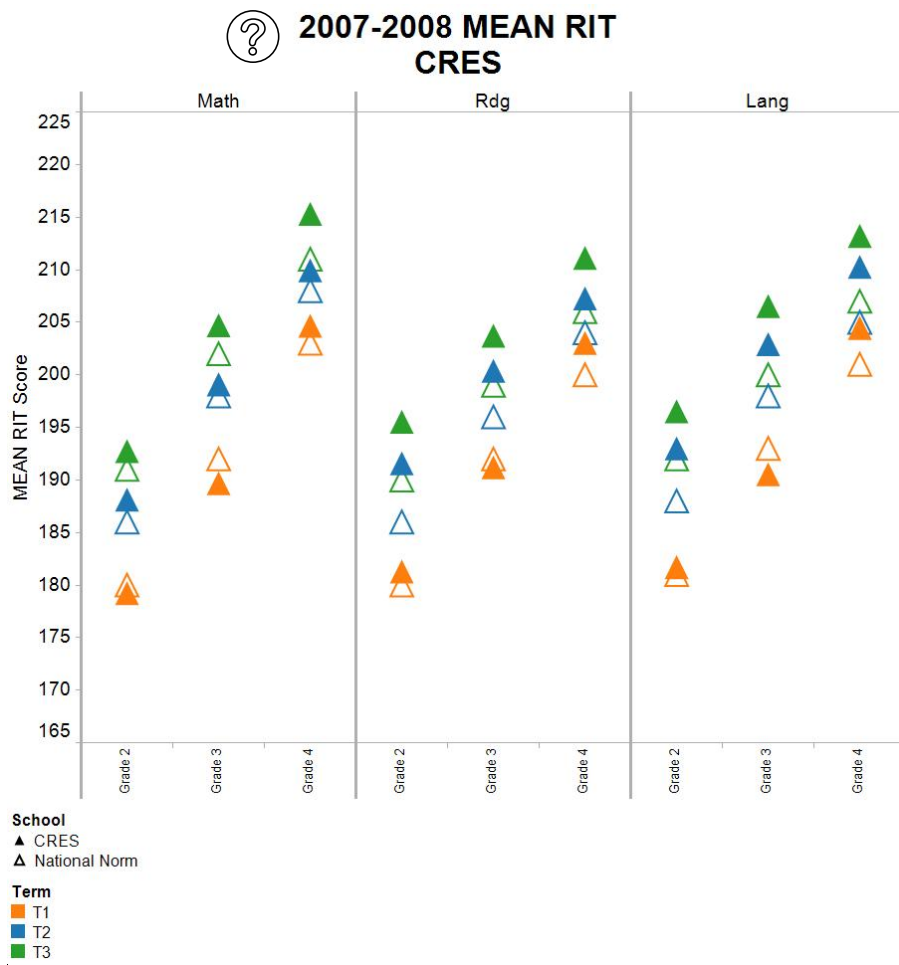

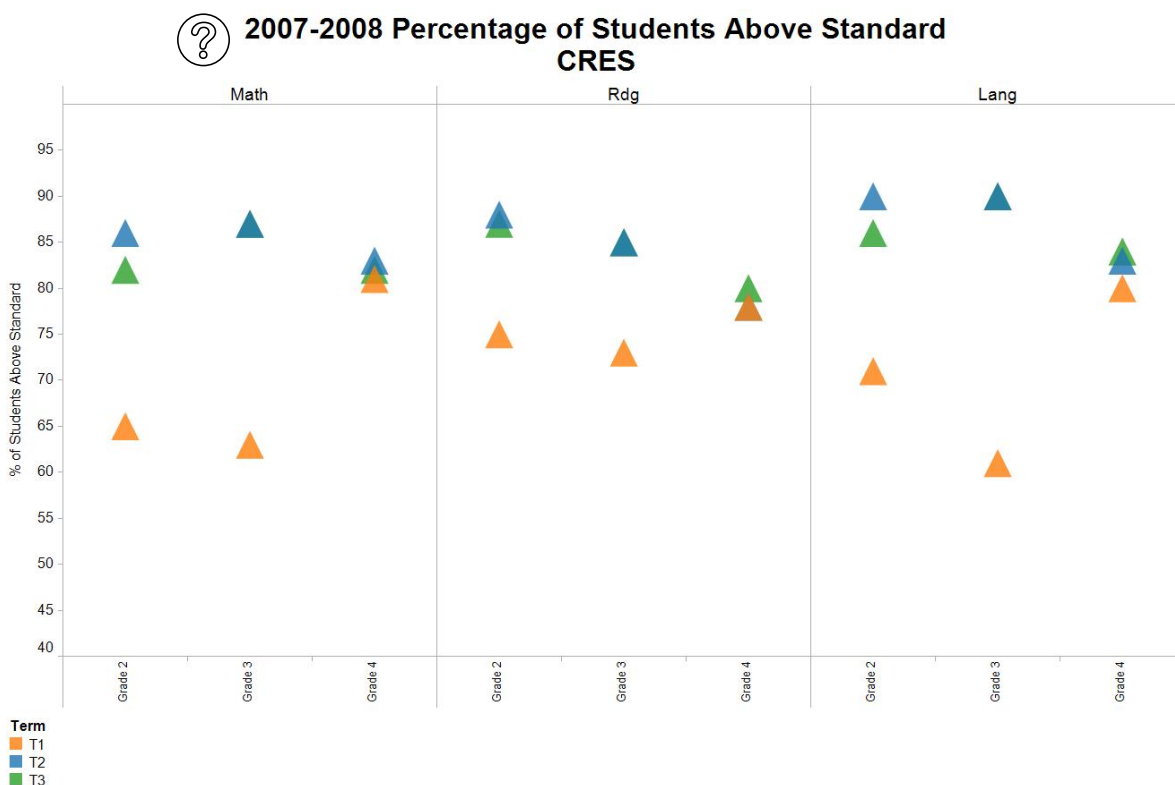

Table 2: The Mean RIT is an average of CRES student RIT scores for that test at that grade level at that time. RIT scores are a continuum across grade levels within three content areas. National patterns show that typically there is more growth within a lower grade level than within an upper grade levels.



Mean RIT growth is reported by trimester (Tri 1, Tri 2, and Tri 3).

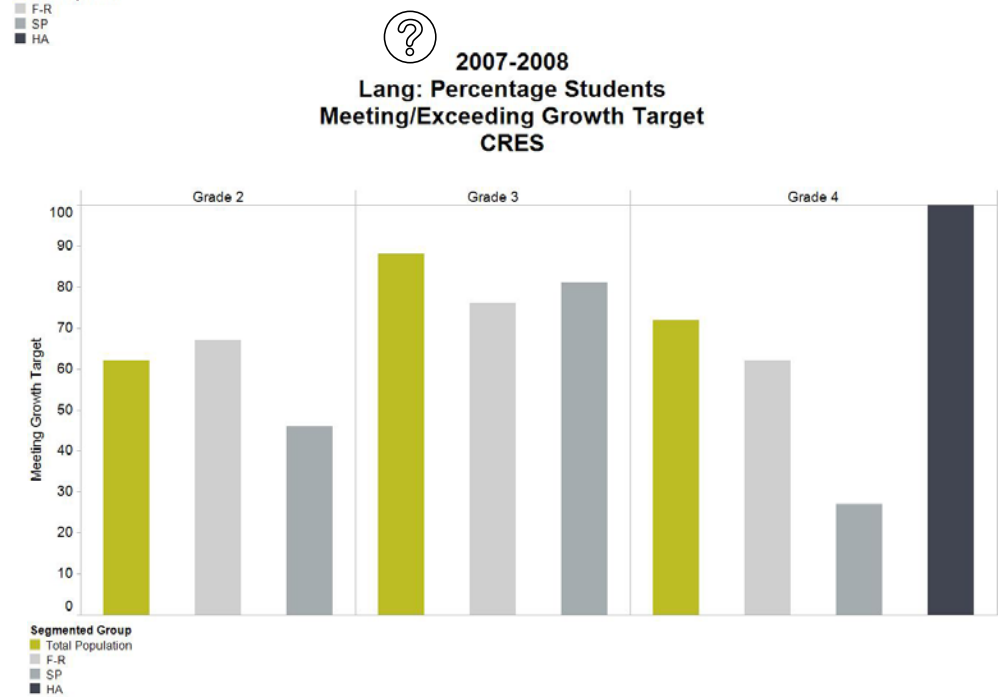
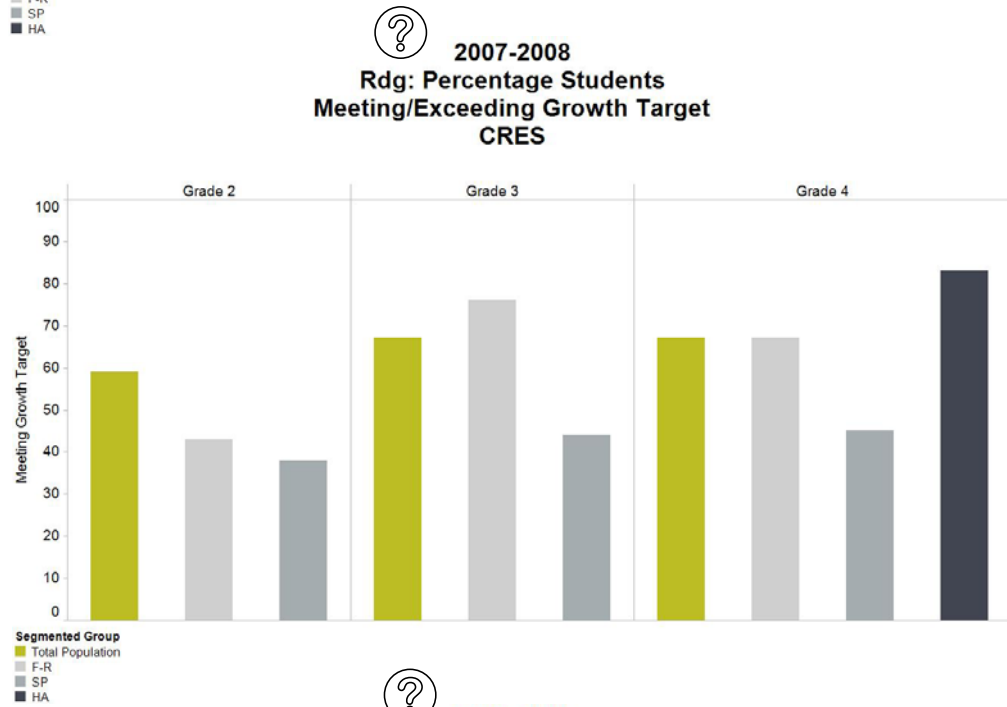
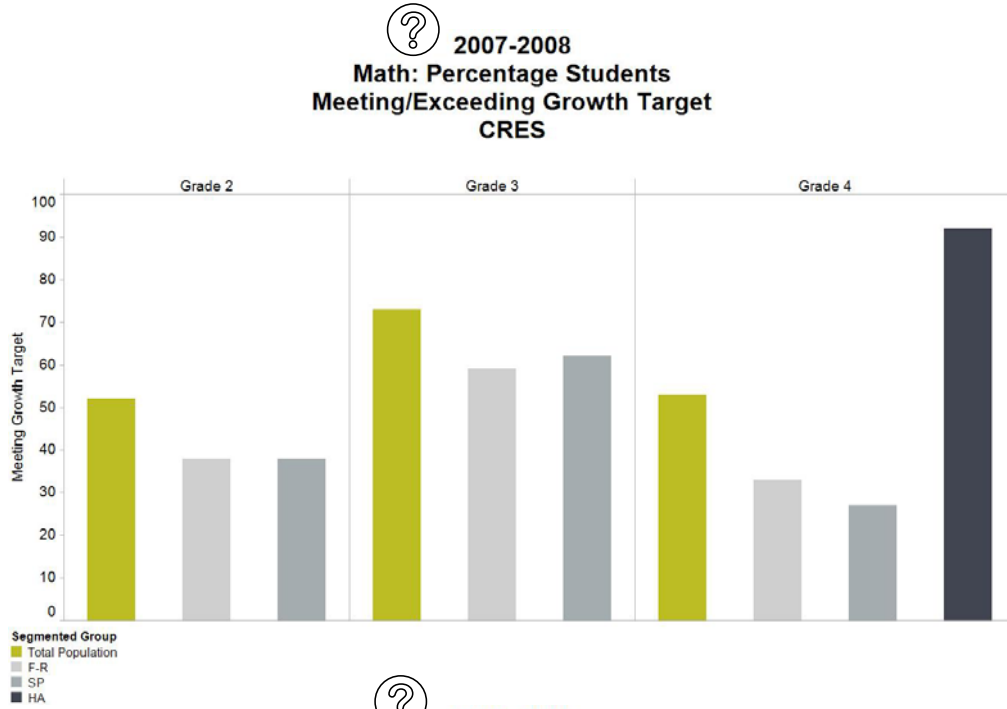
Table 3: 'Above Standard' status is a national comparison of student performance. Students above standard are, at a minimum, within the top two-thirds of all students in the national database. WWS commitment is to continually move below standard students into the above standard range.



Above Standard status is reported by trimester (Tri 1, Tri 2, and Tri 3)

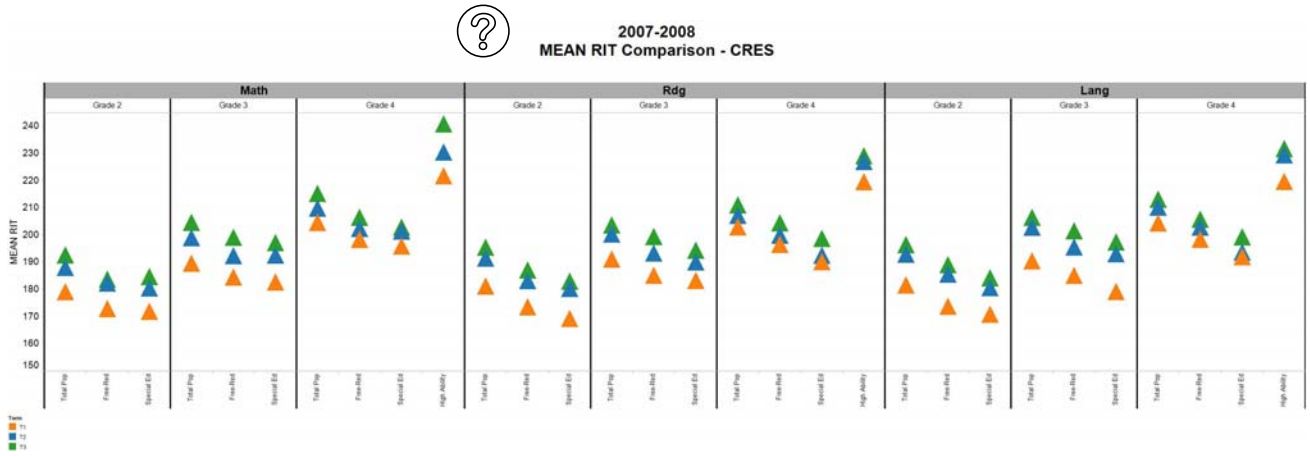
Goal Two: By 2011, the percentage of CRES students within each of the four segmented groups (ESL, Special Education, Free & Reduced Lunch, High Ability) who meet or exceed their individual growth targets will be equal to the overall percentage of students at that grade level.

Table 1 (Three Graphs): Percentages are calculated as the percentage of CRES students in that key segment group at that grade level if more than ten students were identified for that key segment at that grade level.



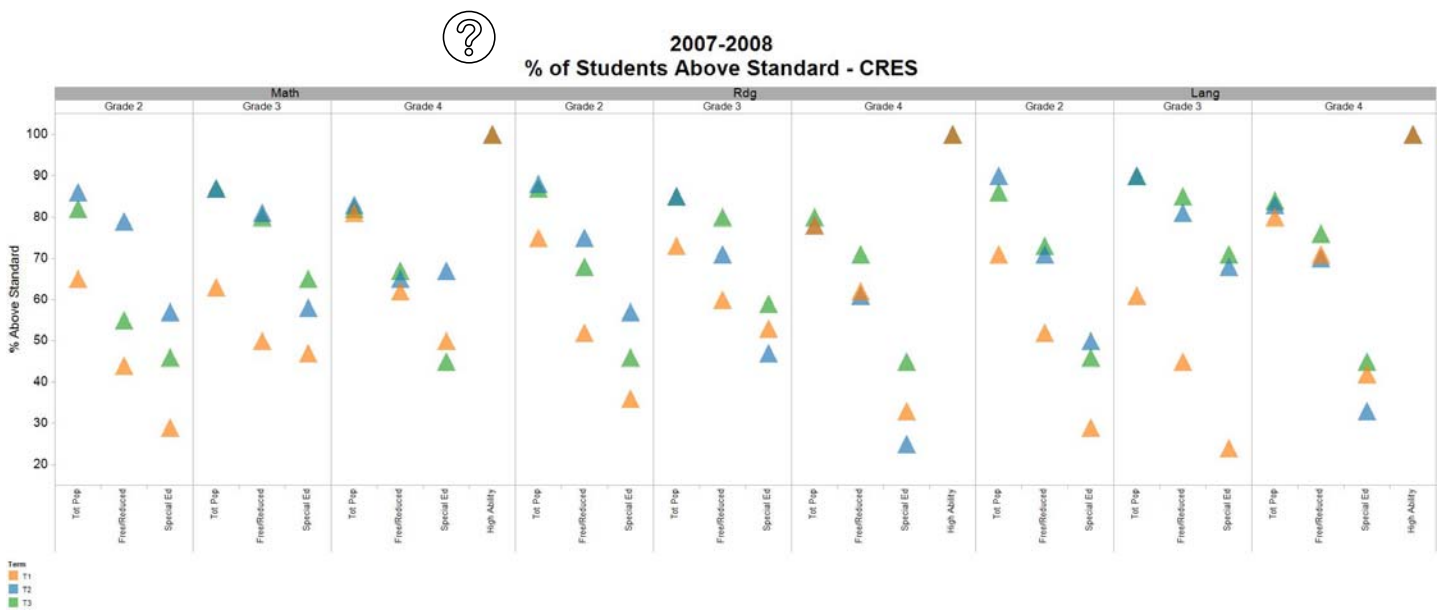
2009-2010 Growth Target Data is a fall to spring measure.

Table 2: The Mean RIT is an average of CRES student RIT scores within that segment for that test at that grade level at that time if more than ten students were identified for that key segment at that grade level.



Mean RIT growth is reported by trimester.

Target Area Two: Safe and Healthy Environment

Goal One: Each building will achieve an exemplary rating during 100% of its safety preparedness exercises.

Table 1: Exemplary rating is defined as percentage of drills completed and meeting all criteria in the district rubric for readiness.

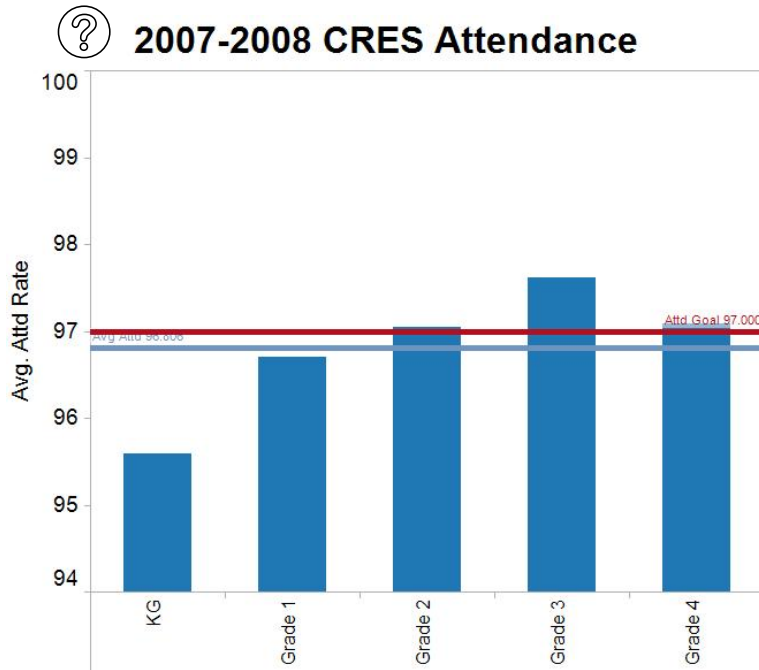

Goal Two: Westfield Washington Schools will maintain a balanced budget by assuring that expenses will not exceed 95% of appropriated funds.
